



Minutes of Pre-Bid Meeting

“ARTHROSCOPY HAND INSTRUMENTS”

The subject meeting was held at conference room of the Administration Block of Mardan Medical Complex Mardan on Thursday February 17, 2022 at 13:00 Hrs in presence of the procurement committee for Goods (Medical Equipment). Attendance sheet attached.

After recitation of the Holy Quran and introduction, Chairman Procurement Committee Professor Dr. Muhammad Said welcomed all the participants and informed that the purpose of this meeting is to discuss the draft bid solicitation documents including specifications and evaluation criteria and to incorporate the suggestion/comments from prospective bidders, so that the draft may be approved by the competent authority once supplemented/amended.

Chairman Procurement Committee Professor Dr. Muhammad Said, further added that the draft document for the subject equipment has been prepared keeping in view the requirements & allocated budget of MMC Mardan, however your comments / suggestions towards improvement will be appreciated and incorporated if agreed by the committee. Dr. Muhammad Tariq and Dr. Abdul Samad being end users of Orthopedic department added here that once the specifications agreed and the firm could not quote accordingly, shall be declared as non-responsive. Maximum 03 (three) deviations not affecting the performance of the product shall be accepted.

While initiating the discussion Manager Procurement, informed the forum that this document has been prepared in light of KPPRA Law and Rules. The bidding shall be conducted under the Single Stage Two Envelops procedure. All the bidders were advised to read these documents thoroughly, however some of the important points were announced as under.

- i. Each firm will carefully fill the cover sheet comprising complete information.
- ii. Each firm will submit affidavit as per sample annexed in this document on judicial stamp paper.
- iii. Late bid shall not be entertained / accepted.
- iv. An affidavit is mandatory in the technical bid that bid security (in original) on FOR rates is placed in the financial bid.
- v. In case a bidder quotes more than one package, they will have to submit individually bids (technical & financial) as mentioned in Bid Solicitation Documents.

- vi. All the relevant documents must be attached with the bid and it is categorically mentioning here that none of the document will be entertained (affecting the bid of the other competitors) once bid submitted and decision will be made on the bid submitted on time prescribed in the advertisement / bid documents.
- vii. Regarding GST all the firms will add 17% (where applicable) as the government has omitted this clause from the relevant law.
- viii. Each bidder will submit Single bid (in original)
- ix. Each bidder shall quote its bid annexure wise along with page numbering.
- x. For specifications each firm shall quote its brand name with proper model / serial number and shall **NOT** use the word "As per specification" or "specifications compliance"
- xi. Each firm is bound to quote the complete instruments as whole given in specifications.

Eligibility Criteria.

None of the bidder raised any objection on eligibility criteria.

Evaluation Criteria.
